

**WAIVER AND RELEASE OF LIABILITY**

***Informed Parent's Consent***

We/I fully understand that our son's/daughter's participation in the Camp may subject him/her to an environment and arrangement that may be out of his/her comfort zone and to various activities that will be strenuous and challenging, including but not limited to the following:

  - a. Obstacle courses that will challenge physical and mental strength.
  - b. Games that may require participants to run alongside other participants on uneven and unlit terrain.

We/I acknowledge that the Camp's activities have inherent risks that could result in injury, or other mishaps, but such risks are reduced by proper safety instruction and gear, sufficient adult oversight and full cooperation of the participants. Hence, we have duly instructed our son/daughter, for his/her safety and well-being and that of the other Camp participants and organizers/volunteers, to fully abide with the Camp's leaders and strictly adhere to the Camp's rules and regulations.

In consideration of the benefits to be derived, and after careful consideration of risks involved, and having full confidence that precautions will be taken to ensure the safety of our/my son/daughter to participate in the Camp, we/I hereby agree to release and hold harmless and waive all injury or other claims and actions of whatever nature which may result from my son's/daughter's participation at and travel to or from the said Camp, we/I may have against Ang Ligaya Ng Panginoon, its Young Adults Program, the Camp volunteers, activity coordinators and/or organizations (all collectively referred to as the Organizers) associated with the Camp.
